Aquatics Training Weekends (Spring)

BSA Lifeguard

April 29, 2022 - May 1, 2022 & May 20-22 2022 (Class begins Friday at 7:00 PM both weekends)

Successful candidates of this two weekend course will receive the following certifications: BSA Lifeguard, Snorkeling BSA, CPR/AED for Professional Rescuer, Standard First Aid. Candidates must be at least 15 years old. This course involves extensive swimming. You must be in good physical condition. Candidates must attend both weekends to complete all certifications. Certifications will be valid for two years upon completion of this training.

Cost: \$200 Registration fee includes all course materials, certification fees and meals (both weekends).

Registration deadline April 14, 2022.

BSA Aquatics Supervisor (Swim & Water Rescue)

April 30, 2022 (8:00 AM - 5:00 PM)

Expands on Safe Swim Defense course and is recommended to conduct safe aquatics activities. Candidates must be at least 15 years old. This certification will allow you to open council pool areas for unit use. Certification is valid for three years upon completion of this training.

Cost: \$45 Registration fee includes all course materials and Saturday lunch. If you take both Aquatics Supervisor courses during this weekend you will receive a \$10 discount off your total fee. Registration deadline April 21, 2022. Online registration and payment only.

BSA Aquatics Supervisor (Paddle Craft Safety - Basic Kayaking/Basic Canoeing)

May 1, 2022 (8:00 AM - 5:00 PM)

Expands on Safety Afloat course and is recommended to supervise basic canoeing or basic kayaking excursions on flat water. Candidates must be at least 15 years old. This certification will allow to open council waterfront areas for use by units (Valid CPR training also required). Certification is valid for three years upon completion of this training.

Cost: \$45 Registration fee includes all course materials and Sunday lunch. If you take both Aquatics Supervisor courses during this weekend you will receive a \$10 discount off your total fee. Registration deadline April 21, 2022. Online registration and payment only.

CPR for the Professional Rescuer Certification/Recertification

May 20, 2022 (6:30 PM - 10:00 PM)

Cost: \$50 Registration fee includes certification fee and all course materials.

Registration deadline May 12, 2022. Online registration and payment only.

BSA Lifeguard Recertification

May 21, 2022 (8:00 AM - 10:00 PM)

Cost: \$50 Registration fee includes all course materials, certification fees, Saturday lunch and Saturday dinner.
