Purpose of the Course

The Trainer's EDGE replaces the Trainer Development Conference (BSA 500) as the required train-the-trainer course for District Training staffs, Wood Badge staffs and NYLT staffs. The purpose of the Trainer's EDGE course is to provide and help develop the platform skills of a trainer. It is meant to supplement the practice offered through Wood Badge and NYLT staff development, with a focus on the participant, while raising the level of skill a trainer brings to the staff experience. Only practice can polish these skills, but this course is intended to "train the trainer" on behaviors and resources while offering hands-on experience in methods and media.

Participant Presentations

In Module 4, participants will make a presentation to the team on a Scouting topic of their choice. The topic each participant selects should be broad enough to apply the learning from the morning sessions. Participants are invited to bring any materials or equipment they need for their presentation with them to the Trainer's EDGE course. Flip chart easels and a projector will already be on site.
